Any Contractor registered with the Central Government / any State Government or any PSU or an agency of international or national repute may participate in the tender, but registration with the Road Construction Department, Bihar will be essential after issue of L.O.A. and before executing the agreement.
- 12. Bids from Joint Ventures are allowed as per the eligibility criteria and other instructions issued by RCD Bihar.
- 13. Detailed NIT can be seen on website www.prdbihar.gov.in or https://www.eproc2.bihar.gov.in or on the Notice Board of the office of the undersigned.
- 14 For participating in the above E-Tendering process, the contractors shall have to get themselves registered with the service provider so that user ID, password and Digital Signature are issued to them. This will enable them to access the website https://www.eproc2.binar.gov.in and.download/participate in E-Tender. For this, intending bidders may contact Eproc2 Helpdesk Details. - 15. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigning any reason there of. No cost what so ever shall be claimed on such account by the bidder.
- 16 Cost of BOQ and Bid Processing Fee (Column-5 & 6 of clause 8) is mandatory to be paid through online model.e. Internet Payment gateway (Credit/Debit card), NEFT/RTGS, Net banking. A scanned copy of valid proof to be uploaded along with the tender documents.
- 17. Earnest money (Column-4 of clause 8) can be paid online or in the form of Bank Guarantee of Nationalised/Scheduled Bank in the prescribed format of SBD (Reference-Engineer in Chief, RCD, Bihar, Patna letter no-5651(E) dated 19.08.2020), as duly endorsed/pledged to Executive Engineer, RCD, Road Division, Nawada. A scanned copy of valid proof to be uploaded along with the tender documents.

The above B.G. shall be issued on/after the start of uploading of bid documents by the employer and before/up to the stipulated last date of uploading the bid by the bidder, shall be applicable. It should be valid for not less than 165 days from last date of uploading of tender documents.

- 18. The bidder has to submit the email ID & Mobile No. of the concerned person of the Bank/Financial Institution from which they has procured B.G. for EMD so that the verification of the same should be done immediately.
- 19. Bidders/ Contractors can access tender documents on the website and must fill them and submit the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall upload scanned copies of all required papers and certificates as required in the eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates. Bidders shall musthave to mention their Mobile Numbers.
- 20. Corrigendum/ Addendum, if any, will be published on the website itself.
- 21. "Bid along with necessary online payments must be submitted through e-procurement portal <a href="https://www.eproc2.bihar.gov.in">https://www.eproc2.bihar.gov.in</a> before the date and time specified in the NIT. The department does not take any responsibility for the delay/Non Submission of tender/Non reconciliation of online payment caused due to non availability of internet connection, network traffic/holidays or any other reason."
- -22. As per department letter no 3987(s) dated 28.04.12, bidders will have to declare by affidavit that they have not been declared defaulter or blacklisted by any State Government/Central Government/Public Undertaking. If such an affidavit is subsequently found to be false, their tender shall not be considered and further legal action shall be initiated.
- 23. The bidder also must enclose an affidavit along with his BID as detailed below.
  - "I, the undersigned, do hereby certify that all the statements made in the required attachments are true and correct and if found fake/forged, the undersigned will be liable to be inflicted upon the FIR and lawful punishment as well as blacklisting"
- 24. The bidder has to provide their Whatsapp enabled mobile No & email ID so that they may be contacted immediately in case of any quarry.
- 25. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
- 26. Contractor will have to deposit additional performance guarantee for seriously unbalanced rate quoted by him at the time of agreement
- 27. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. Bidders should satisfy themselves of download ability/visibility of the scanned & uploaded file by them.
- 28. The bidders are directed to zip their files using WinZip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected
- 29. The bidders must use MS office-2007 or lower version.
- 30. File size should be less than 5MB and should be in MS Word, Ms-Excel, PDF and JPEG formats.
- 31. Estimate cost/ECV may vary, Amount of EMD will be as per amount of BOQ.
- 32. For any information/complaints the departmental help line may be contracted.
- 33. This is SBD based tender so all conditions of SBD shall be applicable. Before uploading tender, bidders are advised to go through the SBD uploaded with the tender document.
- 34. The Bidder must submit their work schedule in the form of BAR Chart.
- 35. If the Contractor fails to complete the work within the time/as per work programme, the agreement can be rescinded and the balance work will be done at risk and cost of the contractor and additional cost incurred on the work to complete the work will be recovered from the contractor as per Rule.
- 36. The Bidder must enclose the list of earlier work done of minimum one similar work whose minimum estimated cost should be equal to 10% of the estimated cost of present work.
- 37. During verification of EMD if it found false, the concerned Bidder would be blacklisted by the department





- 38. As per the RCD, Letter No-448(s) dated-16.01.2020 and Letter No. 4439 (E) WE dated-17.07.2023, the lowest limit of Quoting rate upto 10% (Ten Percent) of the BOQ amount has been cancelled & the bidder has been allowed to quote rate as per his convenience with additional performance guarantee as mentioned below.
  - a. For quoting rate between 0% to 5% below the BOQ amount, the bidder has to submit additional performance guarantee of 0.25% for every 1% below quoted rate of the BOQ amount.
  - b. For quoting rate between 5% to 15% below the BOQ amount, the bidder has to submit additional performance guarantee of 0.5% for every 1% below quoted rate of the BOQ amount.
  - c. For quoting rate between 15% to 20% below the BOQ amount, the bidder has to submit additional performance guarantee of 1% for every 1% below quoted rate of the BOQ amount.
  - d. For quoting rate of 20% below the BOQ amount, the bidder has to submit additional performance guarantee of 2% for every 1% below quoted rate of the BOQ amount.
- 39. Proper affidavit regarding hire/lease/Owned to be procured of equipments with voucher must be uploaded.
- 40. Power of Attorney must be submitted on Rs. 1000 Non Judicial Stamp.
- 41. The charge for advocate welfare fund (stamp charge for oath letter) has been changed to Rs. 25 from Rs. 15. The bidder must submit affidavit with requisite stamp fee otherwise tender will not be valid as per recent Government order.
- 42. The documents issued by Chartered Accountant or the certificates from chartered accountants must have UDIN alongwith CA member no & firm registration no.
- 43. The successful bidder must have to submit character certificate issued from DM/SSP /SP concerned district before agreement as per instructions of letter no 2033(E) dated 11.04.2022.
