9. The bidder must be registered in Road Construction Department, Govt. of Bihar & he has to enclose the latest registration certificate along with the bid.

11. For participating in the above E-Tendering process, the contractors shall have to get themselves registered with the service provider so that user ID, password and Digital Signature are issued to them. This will enable them to access the website www.eproc.bihar.gov.in and download/participate in E-Tender. 12. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigning any reason thereof. No cost what so ever shall be claimed on such account by the bidder.
13. As per Departmental Letter No.- 5651(E), dated- 19.08.2020 (copy attached), only Bank Guarantee of Nationalized/Scheduled Bank will be accepted as Earnest money (EMD) and the same would be verified online. There will be compulsory provision of Bid encryption through Pass Phrase in eproc 2.0 application.

The above instrument(s) shall be fully endorsed/pledged to the Executive Engineer, RCD, Road Division, Nawada, Bank Guarantee should be valid not for less than 180 days from last date of uploading of tender documents.

14. The bidder has to submit the email ID & Mobile No. of the concerned person of the Bank/Financial Institution from which they has procured different instrument for EMD so that the verification of the same should be done immediately.
15. Cost of BOQ, and Bid Processing fee is mandatory to be be paid through online mode i.e., internet payment gateway (Credit/Debit Card), Net banking, NEFT/RTGS" in favour of EXECUTIVE ENGINEER, R.C.D. Road Division, Nawada and Payable at Nawada and scanned copy should be uploaded along with tender document.
16. Bidders/ Contractors can access tender documents on the website and must fill them and submit the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall upload scanned copies of all required papers and certificates as required in the eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
17. Corrigendum/ Addendum, if any, will be published on the website itself.
18. "Bid along with necessary online payments must be submitted through e-procurement portal www.eproc.bihar.gov.in before the date and time specified in the NIT. The department does not take any responsibility for the delay/Non Submission of tender/Non reconciliation of online payment caused due to none availability of internet connection, network traffic/holidays or any other reason."
19. As per department letter no 3987(s) dated 28.04.12, bidders will have to declare by affidavit that they have not been declared defaulter or blacklisted by any State Government/Central Government/Public Under taking, if such a affidavit is subsequently found to be false, their tender shall not be considered and further legal action shall be initiated.
20. The bidder also must enclose an affidavit along with his BID as detailed below.
"I, the undersigned, do hereby certify that all the statements made in the required attachments are true and correct and if found fake/forged, the undersigned will be liable to be inflicted upon the FIR and lawful punishment as well as black listing"
21. The Bidder must provide their current whatsapp enabled mobile no. and Email-id show that they may be contacted immediately in case of any quarry.
22. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
23. In the unlikely event of the server for www.eproc.bihar.gov.in being down for more than two consecutive hours (in the period from midnight to closing time for receipt of tenders) on the last date of receiving of bid, the last date of the same shall automatically be extended to next working day till the last receiving time stipulated in the original NIT.
24. Bidder will have to deposit additional performance guarantee for seriously unbalanced rate quoted by him at the time of agreement as per RCD letter No.3376 (E) WE dated 17.08.10
25. File size should be less than 5MB and should be in MS Word, Ms-Excel, PDF and JPEG formats.
26. Estimate cost/ECV may vary, Amount of EMD will be as per amount of BOQ.
27. For any information/complaints the departmental help line (no-18003456161) may be contracted.
28. This is F2 based tender so all conditions of F2 shall be applicable.
29. The bidder must submit their work schedule in the form of bar chart.
30. If the Bidder fails to complete the work within the time/as per work programme the agreement can be rescind and the balance work will be done at risk and cost of the contractor and additional cost incurred on the work to complete the work will be recovered from the contractor as per Rule.



31. As per RCD Notification No.-5737(S) dt. 07.05.2027, If earnest money found invalid in verification the bidder will be blacklisted.
32. As per the RCD, Letter No-448(s) dated-16.01.2020, the lowest limit of Quoting rate upto 10% (Ten Percent) of the BOQ amount has been cancelled & the bidder has been allowed to quote rate asper his convenience with additional performance guarantee as mentioned below.
 - a. For quoting rate between 0% to 5% below the BOQ amount, the bidder has to submit additional performance guarantee of 0.25% for every 1% below quoted rate of the BOQ amount.
 - b. For quoting rate between 5% to 15% below the BOQ amount, the bidder has to submit additional performance guarantee of 0.5% for every 1% below quoted rate of the BOQ amount.
 - c. For quoting rate between 15% to 20% below the BOQ amount, the bidder has to submit additional performance guarantee of 1% for every 1% below quoted rate of the BOQ amount.
 - d. For quoting rate of 20% below the BOQ amount, the bidder has to submit additional performance guarantee of 2% for every 1% below quoted rate of the BOQ amount.
33. As per Department Letter No.- 3608(E), dated- 22.05.2020 (copy attached), All the bidders should submit their affidavit having Rs. 25/- for Advocate Welfare Fund in place of Rs. 15/- being paid earlier.
34. Prior to the Agreement successful Bidder (Proprietor/Partner/Executive Director) whatever applicable has to submit character Certificate issues by District police in proper format as per Engineer-in-Chief Letter No.- 2033 (E) Dated 11.04.2022.
35. As per prohibition, Excise & Registration Department, Bihar Notification No. 1026 dt 15.02.213, It is mandatory that power of attorney, if applicable, should be on Rs. 1000/- Stamp.
